- The Group Environnemental Policy is based on five Principles: Leadership Compliance Environnemental protection Stakeholder collaboration Continual improvement.
- Volkswagen Financial Services (VWFS) aligns with the Volkswagen Group's ESG principles: "We drive the transition to emission-free mobility along the Volkswagen Group's ESG principles." VWFS aims to achieve carbon neutrality by 2030 for its products, with a specific focus on reducing its carbon footprint in operational activities.
- Overview of major environmental initiatives undertaken by VWFS France :
- ✓ Waste Management: majority of waste at our sites is recycled with active promotion of material reuse.
- ✓ Energy Efficiency: Roissy site has achieved environmental certification standards (building certified HQE) and has a green roof to improve thermal isolation.
- ✓ Biodiversity Initiatives: Both Villers-Cotterêts and Roissy sites host bee hives to contribute to environmental conservation.
- ✓ Campus initiative: Development of new mobilities ('Forfait Mobilité Durable' & carpooling)

 - Our global responsibility is centered on preserving our planet and upholding human rights throughout the entire process of creation and sales.
- When will Volkswagen Group decarbonization plans be implemented?
 - \checkmark Volkswagen Group is targeting a carbon-neutral balance by 2050.
- What potential environmental protection measures are in place for production?
 - ✓ A strategy has been implemented to stop machines and equipment, lowering the baseline load and conserving energy, reducing emissions, optimizing resource usage, minimizing waste.
- What examples of daily actions should be taken in the workplace to reduce CO2 emissions?
 - ✓ Avoid printing.
 - ✓ Increase refrigerator temperatures.
 - ✓ Reduce the use of heating and air conditioning.
 - ✓ Encourage carpooling/public transportation.

- What is the Act on Corporate Due Diligence Obligations in Supply Chains (LkSG) ?
 - ✓ We applies the LkSG, extending across the entire supply chain, with requirements spanning environmental and social standards, incorporating considerations for human rights and forced labor.
 - ✓ The LkSG prohibits the collection, storage, and disposal of environmentally harmful waste.
 - ✓ Bans the production of products treated with mercury.
 - ✓ Forbids the export and import of hazardous waste.
- Our Environmental Compliance Management Systems* ensure that ecological aspects and obligations in our business activities are identified and appropriately considered. What are the main objectives arising from the Environmental Compliance Management System (ECMS)?
 - ✓ Guarantee the qualification of all employees and ensure their awareness and commitment to environmental protection.
 - \checkmark Identify and assess opportunities and environmental risks.
 - ✓ Outline the duties and responsibilities of employees.
 - ✓ Adhere to binding obligations.
 - What actions should be undertaken in the case of a company regulations breach?
 - ✓ Employees can report environmental concerns directly to team spokespersons, foremen, or the environmental protection specialist (SfU). Additionally, a whistleblower system is in place for reporting serious rule violations.
